### THE HUNTER FAMILY

Jacob Hunter# and has wife, Polly, acquired 640 acres on Sevannah Creed, Waters of Congree River, in the District of Orange-burgh by deed (2) from the State of South Carolina, on September 5, 1785. The "plantation" was approximately fourteen miles below Columbia, on the road to Charleston. Soldiers of the Revolution were given the privilege of buying lands from the State, the consideration in this case being "fourteen poinds, eighteen shillings, Sterling".

On October 30, 1775, a petition to form a company of Volunteer militia by Andrew Cumming and seventy men (including Jacob Hunter) from Orangeburgh and near-by Districts, was approved by Henry Laurens, President of the First Council of Safety, at Charles Town. (3) This company was attached to the Colleton County Regiment of Foot.

The War Department advises (4) that Jacob Hunter also served in the 3rd South Carolina Regiment, commanded by Colonel William Thompson. He enlisted July 6, 1777.

Jacob's residence at the time of his enlistment has not been determined, and many of the earlier records are no longer available. The court house at Orangeburgh was burnt by General Sherman. Neither has it been ascertained when he sold his "plantation" on Savannah Creek. It has been said that the Hunters came originally from North Carolina, and settled in Richland County in 1763.

The South Carolina census of 1790 lists but one Jacob Hunter, and he and other Hunters in Richland County are listed below:

Jacob and his family went to Robertson County in 1793 (1) and on October 15, 1798, Jacob Hunter acquired 220 acres on the north side of the Cumberland River and on both sides of Sycamore Creek in Robertson (now Cheatham) County. (5)

## Among his neighbors were:

- 1. Thomas Hunter, born 1763 in Halifax County, North Carolina (7).
  Drafted 1778 in The Revolution from Richland County, Så. Car.
  Moved to Jefferson, Montgomery, and finally to Robertson County,
  Tenn. He is believed to be a cousin or brother of Jacob Hunter.
- 2. Allen Hunter, whose deed was witnessed by Thomas Hunter, is also mentioned in the settlement of Jacob's estate (10). Died before 1833.
- Jacob's brother. He had a son Dempsey; also a brother Dempsey (exhibit 12) who sold land in Montgomery County 1809 (Book 3, page 499). David mentioned in the settlement of Jacob's estate. Davidson County Will Book 3, pages 145 and 159.
- 4. Frederick Hunter lived on the Red River, some distance away, and nothing is known of him.
- 5. Henry B. Hunter of North Carolina lived at Washington Corners. Said to have been a nephew of Jacob.
- 6. Matthew R. Hunter, heir of Allen Hunter; Note--Will Book 2, in Robertson County is not indexed, and the Wills in Montgomery County were not examined. Apparently Matthew sold out in 1833, and possibly moved.

The children of Jacob and Polly, as related by their granddaughter, Aunt "Duck" Lee:

- Emmanuel (Manuel) born 1787 in South Carolina. Married Judith, daughter of Braxton Lee, in Davidson County May 20, 1808. (Marriage Book, Vol. 1, page 91)
- 2. Elizabeth, born in South Carolina. Married Thos. J. Freeland, son of George Freeland, one of Nashville's earliest settlers (1779) and member of the first court of Davidson County.
- 3. Isaac (lived on White Creed). See Davidson County deeds.
- 4. Matthew, died 1848. (Matthew R. Hunter merried Martha M. Raton 3/4/1826 in Davidson County, Book 1, page 310) also see marriage to Elizabeth Moody, born 11/13/1813, died 11/16/1849. (per letter of Mrs. G. R. Brewer)
- 5. Polly
- 6. Stephen (probably named after Stephen Lee, who settled near Ashland City, Tenn.

The above number (6) councides with that shown in the division (11) of Jacob's estate. Jacob died in 1806, without a will, and an inventory (9) of his estate was filed by the administrators Polly Hunter and Bractén (Braxton) Lee in the Court of Davidson County at the January 1807 session.

The widow, Polly Hunter, and Braxton Lee were married May 20, 1808; and on the same date Polly's son, Manuel, married Judith, daughter of Braxton Lee. See Davidson County Marriage Book 1, page 91. (See Exhibit 22 for their children)

There seems to be no doubt that the family came from North Carolina, and immigrated from Ireland. Thomas Hunter states that he was born 1763 in Halifax County. (7) C.M. Hunter also states that his father, Dempsey, and Uncle David Hunter came from North Carolina, but does not name the county.

Our examination of the Abstract of Wills of Halifax County, compiled by Susie Brickell Anderson (176101838) reveals no Hunters. Halifax was formed in 1758 from Edgecombe County. Further research should be done in these two counties.

It is said (1) the Hunters were of Irish stock. C. M. Hunter in his "Sketches of Western North Carolina" says "Many Hunters immigrated to Charleston, South Carolina in 1751 from Ireland", including Humphrey, Henry, etc.

### MANUEL AND JUDITH LEE HUNTER

Emmanuel (Manuel) Hunter, born September 17, 1737, in So. Carolina. Listed in the 1790 census in Richland County, So. Carolina. Moved to Robertson (now Cheatham) County, Tenn., when Manuel was six years old. Lived on the north side of the Cumberland River and Sycamore Creek. Married May 20, 1808, Judith Lee (Davidson County, Tenn. Marriage Book 1 page 91). Judith, daughter of Brackston and Elizabeth Hatcher Lee, was born in Goochland County, Va., January 6, 1791; died August 8, 1852. Braxton Lee, born August 2, 1766 in Fluvanna Co., Va. Elizabeth, daughter of Archibald Hatcher, born July 7, 1768, died November 23, 1807. leaving eight children (See Exhibit 25).

In the War of 1812, Capt. Abraham Allen's Company, First Regiment (Mapiers). (Napiers) West Tennessee Militis, from Montgomery County, and was honorably discharged May 26, 1814. This company was under General Andrew Jackson, its principal engagements being against the Creek Indians. He re-enlisted June 17, 1814 as an ensign in the 23rd Regiment from Robertson County. Acquired 122 acres on Block House Branch and Sycamore Creek from Andrew Stewart on November 1, 1812 (Recorded in Robertson County, Deeds "J", page 295) and sold it November 8, 1815. (Deed Book "L", page 458)

In 1824 he, his wife, and three sons, the seven (big-foot)
Sanders brothers, three Moakes, Roderick Reed, and Wilse Gower, with
their families comprised a wagon train that caome to Williamson County,
Illinois. Hanuel entered land in 1829 in Lake Creek Township. The
father of old Dr. Ben Felts, of Tennessee, lived with Manuel until he
completed his own home.

During the Black Hawk War, Manuel served as a corporal in Captain Armistead Homman's Company of Illinois Mounted Volunteers against the Sac and Fox Indians, enrolled Mune 15, 1832, discharged October 17,

1832. This Company was in Abraham Lincoln's regiment. Manuel's son, Jacob, was also a member of his company.

After the death of Judith, August 8, 1852, Kanuelmarried Mary Bess, a widow, on October 2, 1852 (by Jesse Spiller, J.P.) at Marion, Illinois. By this marriage there were twins--Milly Ann and Lydia Ann, and two others. Mauel Ried January 7, 1874 and was buried at the Bethlehem Cemetery, 3 miles east and north of Marion, toward the Scranton Mine. His pension record WC 9 305 is attached as Exhibit 13.

To Manuel and Judith there were born 13 children:

He also made coffins and in burying victims of the cholera plague, himself died 8/25/1866 of the disease. Buried at the family cemetery wouth of Johnston City, Ill. Mr. James Jackson "knew him well", said-Thomas "was tall, broad shoulders, with black wavy hair, and very courteous".

After retiring from business they moved back to Marion where Emma became a leader in the Christian Science Church. Her death occurred June 3, 1948, at Mation, Illinois.
  - graduated from Marion High School 1906, Gem City Business College 1907, attended University of Illinois and Northwestern. Worked in Chicago as an accountant for Price Waterhouse & Co., Arthur Anderson & Co., also as branch accountant for Booth Fisheries Co. at Pittsburg, Buffalo, etc. Passed the C.P.A. examination (Ill.) 1915. History of Gallatin, Saline, Hamilton, Franklin, and Williamson Counties, Illinois, published 1887 by Goodspeed (page 904) and probably contributed by the Rev. Dempsey Hunter.

### The Rev. Allen Hunter

"Rev. Allen Hunter, minister, farmer, and pioneer citizen, was born in what is now Cheatham County, Tenn. in 1813, the fourth of thirteen children of Manuel and Judith(Lee) Hunter. The father, born near Charleston, S.C., in 1787, of Irish stock, was the son of a revolutionary soldier, who moved to Robertson County (1), Tenn., when Manuel was but six years old (2), spending his life as a carpenter, and dying about 1817. Manuel's home life and education was followed by his marriage, when twenty years old, to the mother (Judith Lee) of our subject. Soon after her death he married Mary Bess, who still survives him, and by whom he had four children. In 1826, he located on our subject's present farm, which he sold to the present owners. and died in this county (Williamson) January 7, 1874. He was a farmer, a soldier in the Black Hawk War, and under Gen. Jackson in the war of 1812. The mother (Judith Lee) was born near Richmond, Va., in 1791, died in 1852. Both weremembers of the Primitive Baptist Church. Allen remained at home until his majority, receiving but six month's school advantages in the sparsely settled region of his home. In 1838 he married Elizabeth, daughter of Rev. Charles and Mary Lee, natives of Virginia and Kentucky respectively. She was born in 1820 in Illinois. Eleven of fifteen children are living.

"Dr. Charles T., of White County; Aaron M. attorney in Kansas; Celia A., widow of Jessie Rawls; Tolitha, widow of Isasc Perry; Delcenia; Rev. Dempsey A., of Lake County, Ill.; Lafayette, postal clerk on the Cairo Short Line; Noah, a teacher; Marion J., a farmer; Sarah E., wife of John S. Perry, and Phila, a teacher. Excepting the years 1841 to 1844 in Jackson County, our subject has since his marriage, lived in Williamson County, and since 1852, when he bought it, he lived on the old homestead of 120 acres, all the fruit of his own energy and care. For over forty-four years he has been a minister of the Primitive Baptist Church, very prominent throughout the southern part of the State, as a leader in the Church and an esteemed man, especially in the vicinity of his youth. He is a Democrat and first voted for Van Buren. He belongs to the F. M. B. A. He, his wife, and seven children belong to the Primitive Baptist Church and two are members of the Christian Church".

- November 17, 1839 the town of Marion laid out lots, among the buyers was John D. Sanders.
- 474 Following the Civil War, many gangs infested the north part of the county. George Cox (father of Emma Cox-page 8) was attacked in his house and fired on several times.
- 515 The first church in the county was built in 1819 on the John D. Sanders farm.
- Among the first Baptist ministers in the county was Rev. Charles Lee, who organized Bethlehem Church about 1830. (His daughter, Elizabeth, married Allen Hunter-see page 6).

A. Luke Ralls, farmer and pension agent, was born in his 933 present residence in Lake Creek Township, in 1843, the seventh of eight children of Luke and Milbery Hunter Ralls, natives of Robertson County, Tenn., Born about 1802 and 1810 respectively. The father, of Welsh-English stock, was the son of Luke Ralls, St., native of near Petersburg, Va., and a pioneer

The father came to Williamson County in 1822, and in 1826 married and settled on our subject's present home where he spent his life as a farmer, cooper, and shoemaker, and one of the county's earliest settlers. The wild animals suffered from his excellent markmanship and he was familiarly known and esteemed throughout the county. He died April 11, 1848.

The mother, a daughter of Manuel Hunter, mentioned elsewhere, is supposed to have been a cousin of the Henry Hunter who killed the British General, Packenham, at the Battle of New Orleans. She died Warch 15, 1864, a member of the United Baptist Church.

Their children are Mrs. Sidney A. Daugherty, Mrs. Margaret E. Moake, George W., Mrs. Mary M. Ward, our subject, and William G., three of whom are living on the old home place of their birth, an 80 acre farm on Bear Creek, so name from the Billing of one of bruin's species on its banks, five miles northwest of Warion. The farm belongs to George W., and our subject; the former born 1837, served from August 1862 to July 1865 in Company F, 128th Illinois, afterward in Company P, Ninth Illinois Kounted Infantry, in nineteen important battles and thers, without a wound, or capture or absence from duty, and was one year on the Solomon Valley Railway (Kansas), and three years fore-man of a section on the Kansas Pacific Ry., near Lawrence, Kan., since when he has been a farmer. Our Subject has been pension for the last eight years. He was educated chiefly at Carbondale, taught for several years, and for many years served as school trustee. Both are earnest Democrats and Odd Fellows. The latter is a Mason, and member of F.M.B.A. and of the Christian Church of which he is a prominent worker. He is secretary of the Ferges Sunday School and secretary of the County Sunday School Association in 1883-84.

#### ROBT. WEAKLEY TO JACOB HUNTER OCTOBER 15, 1798.

This indenture made this lith day of October Ome thousand seven hundred and ninety eight, between Robert Weadley of this County of Davidson, and State of Tennessee, of the one part, and Jacob Hunter of Robertson County and State aforesaid, of the other part:

WITNESSETH, That for and in consideration of a sum of \$ 220.00 in hand paid to the said Robert Weakley before the signing and delivering of these presents, the receipt whereof he doth hereby acknowledge, hath bargained and sold, aliened and confirmed and by these presents doth bargain, grant, sell, alien, confirm unto the said Jadob Hunter his heirs and assigns forever all that tract as parcel of land situated, lying and being on the N. side of the Cumberland River, and on both sides of Sycamore Creek in the state aforesaid:

Beginning at a white oad and small sugar tree on the N. bank of said creed; runs S. 46 chains 40 links to a stake; thence E. 47 chains 50 links to the middle of said creek; thence north with Purnells line in all 46 chains 40 links to a stake, Jacog Moaks corner; thence with Moaks line West and passing his corner in all 47 chains 50 linds to the beginning, containing 220 acres be the same more or less, it being the S. end of a 640 acre tract, warrant of which in No. 3982.

To have and to hold the aforesaid tract or parcel of land with all advantages, hereditaments and appurtenances thereunto belonging or in anywise appertaining unto the said Jacob Hunter, his heirs and assigns forever, and the said Robt. Weakley doth for himself, his heirs, executors, and administrators doth covenant and agree to and with the said Jacob Hunter, his heirs and assigns to warrant and forever defend the aforesaid bergain premises unto the said Jacob Hunter, his heirs and assigns against all persons whatsoever lawfully claiming the aforesaid bergain premises in witness whereof the said Robt. Weadley hath hereunto set his hand and seal the day date first above written.

# PENSION FILE OF THOMAS HUNTER - VETERANS ADMINISTRATION S4.411

State of Tennessee County of Robertson) 88

On the third day of April 1833 personally appeared before me Henry Frey one of the Acting Justimes of the Peace in and for such County of Robertson. Thomas Hunter a resident of the County of Robertson and State of Tennessee aged 70 years who being first duly sworn according to law doth on his corporal oath make the following declaration in order to obtain the benefit of the Act of Congress passed June 7, 1832.

That he entered the service of the United States under the following named officers and served as hereunder stated

He states that he was drafted for a term of three months in the year 1778 in the State of South Carolina, Richland County, and entered the service under Robert Gooden, Colonel; William Summers (Lumnars) Captain; and Joseph Culpepper, Lieutenant. He marched to Charleston in the State of South Carolina was stationed there till his term of service expired. He was then dismissed and sent home. There was no regular officers at Charleston during the term he was stationed there. He states that he has been much afflicted ever since the Revolutionary War and for the last eighteen years everely, by reason of which, together with old age he cannot recollect the regiment to which he belonged.

He further states that after his return home from Charleston he went to what is now called East Tennessee where he again entered the service as a substitute for a man by the name of Council(?) Jones for a tetal of three months in the year 1779 under John Sevier, Colonel; Valentine (?) Sevier, Captain. He was -----(?) on the waters of Holston River, the place not now recollected, was marched against the Cherokee Indians at what was then called the Valley Towns (?), destroyed their towns and killed 17 Indians and took 22 prisoners. We took the prisoners to Noluhusky River and delivered them up to the proper authorities. After the expiration of the second term he still remained in East Tennessee. He states that for the reasons before stated he cannot recollect the day nor the month when he entered the service, neither the time at which he quit the service.

The applicant further states some time after his second term expired he again was drafted for a term of three months service in the year 1780 under John Sevier, Colonel; Valentine (?) Sevier, Captain. He was roundevoused near the Wautauga River in what is now called East Tennessee. He marched with the other troops to Kings Mountain! He was not in the battle at Kings Mountain when Ferguson was defeated. The horsemen were marched forward and were in the battle. The footmen of which he was one were left behind and did not arrive until the battle was over. Colonel Campbell was Commander in Chief. He states that he was marched from Kings Lountain toward Salesbury, North Carolina, with the prisoners, though he did not go to Salesbury but was permitted to return.

#### ETHIBIT 7 (CONCLUDED)

The applicant further states that he served in the Revolutionary War in the three services, in all nine months.

The applicant further states that he was born on the 17th day of Larch in the year 1763, and as he was informed by his parents, in the state of North Carolina, Halifax County. His father moved when he was an infant to the State of South Carolina, Richland County.

That he has a record of his age in his papers thich was furnished him by a cousin of his. That after the Revolution he resided some time in the State of South Carolina, Richland County, where he resided when he entered the service. He than moved to Spartenburgh, South Carolina. He then moved to East Tennessee, Jefferson County. He then moved to West Tennessee, Montgomery County. He then moved to Robertson County where he now resides. He further states that he never received any written discharge of any of the times which he served. He further states that he can prove by Conrad Coon his Character for veracity and his belief of his services in the Refolution.

The applicant further states that he has no documentary evidence and that he knows of no persons living by whom he can prove his services. He thereby relinquishes every claim whatsoever to a pension or an annuity except the present and declares that his name is not on the pension roll of the agency of any state.

My father's name was Demps also-would be 102 years old if he were living. He died at 87 and had two other brothers, one also died at 87 and one at 91. So you see we are rather a long life set. I am only 78, and still spry in some respects.

My grandfather came from North Carolina and settled in Cheatham County, and Uncle David settled in Davidson, on White's Creed 10 or 12 miles north of Nashville, et., etc.

Witnesseth that the said Braxton Lee in consideration of his desire to promote the Christian religion and to encourage morality has gratuitously given, granted and conveyed to the above Commission two acres of land on the North side of the Public Road opposite his house where he now lives and including the new meeting House or Church now being built, to be laid off in such a manner as that

the Church shall be made the center of the ground and he the said Lee further grants free use of the Spring but reserves his title in the same. Dated Nov. 10, 1834.

(John and Braxton Lee were cousins and came from Fluvanna County, Va., prior to 1800. His daughter Judith married Manuel Hunter. Braxton married Polly, (Jacob Hunter's

#### War of 1812 Record of Dempsey Hunter

#### Veterans Administration

October 11, 1939.

Dear Sir:

Reference is made to your letter in which you request the War of 1812 record of Dempsey Hunter, of Montgomery County, Tennessee.

The data which follows were obtained from the papers on file in pension claim, W.C. 30882, based upon service of Dempsey Hunter in the War of 1812.

Dempsey Hunter volunteered in Kontgomery County, Tennessee, and served thirteen days as private in Captain Mohn Weakley's company of Tennessee militia in the "Sandy River Expedition". He enlisted next December 10, 1812 and served as private in Captain James Hambleton's (Hamilton's) company of Tennessee militia on the your to the Natchez Country and continued until April 22, 1813 when he was discharged at Nashville, Tennessee, by Major General Andrew Jackson. He enlisted next and served from September 26, 1813 until December 28, 1813 as private in the First Regiment of Tennessee Volunteers, under command of Colonel E. Bradley, and was discharged at Fayetteville, Tennessee.

Dempsey Hunter applied March 21, 1851 for the bounty land which was due under the Act of September 28, 1850 on account of his service in the War of 1812. He was then a resident of Montgomery County, Tennessee, aged fifty-six years; the date and place of his birth and names of his parents were not given. He was allowed eighty acres of bourty land on warrant #33552. He applied May 15, 1855, for the additional bounty land which was due under the Act of March 3, 1855. He was allowed eighty acres of bounty land on warrant #24678.

Dempsey Hunter was allowed pension on account of his service in the War of 1812, on his application executed May 18, 187. He resided then in Thomasville, Cheatham County, Tennessee. He died December 19, 1879.

Dempsey Hunter married the first time, Lucretia Nicholson; they were married September 15, 1816 at her father's home in the vicinity of Thomasville, Cheatham County, Tennessee; the names of her parents were not designated. She died December 2, 1842. The soldier married the second time, Mrs. Mary Ann Jones, the widow of Mordan Jones, who died May 17, 1843; the maiden name of Mary Ann was not given. This second marriage was solemnized November 16, 1844 by Rev. William Randle in Robertson County, Tennessee.

Mary Ann Hunter, the soldier's widow, resided in Thomasville, Tennessee, in August 1880, at which time she was aged seventy-five years, the date and place of her birth were not given.

#### EXHIBIT 17 (CONCLUDED)

In 1814, one B. Nicholson was present when Captain John Weakley signed the discharge of Dempsey Hunter. In 1871, G. Nicholson resided in Cheatham County, Tenn., and was present when the soldier, Dempsey Huhter, made application for pension; in 1880, J.J.Nicholson and J.K.Felts were present in Thomasville, Tennl, when Mary Annn Hunter made affidavit in regard to her husband'd death. Said Mary Ann Hunter referred then to James Hunter, her attorney, but did not give his address. No relationship between these persons and the soldier's family was stated.

If you desire information in regard to the location of the land which was granted on account of service of Dempsey Hunter in the War of 1812, you should address the Commissioner, General Land Office, this city, and furnish the following data: bounty land warrant #33552-80-50 and bounty land warrant #24678-80-55.

#### JACOB HUNTER OF NORTH CAROLINA

"Many Hunters immigrated to Charleston, South Caroline in 1751 from Ireland and came to North Carolina by Wagon" -- Wheeler's History of North Carolina.

#### YAKE COUNTY

November 7, 1939.

"I have checked over the records in the Wake County Court House(wills and deeds--especially deeds) and find that there were two Jacob Hunters in Wake. One settled in Wake about the same time that Isaac Hunter (the two Isaacs) settled-1778 or thereabouts. The other Jacob was the son of Isaac who lived on Swift Creek and signed himself Isaac Hunter "of S.C.", meaning South Creek or the creek in southern Wake--Swift Creek.

It is evident that Jacob, the son of Isaac of Southern part of Wake lived in Wake until his death. The other Jacob, disappears from the records, after his land transactions with Isaac Hunter, Planter, in 1786 and 1788. He might deserve consideration as your man, although the records do not indicate what became of him. There is no will of a Jacob Hunter in Wake and no settlement nor administration that I was able to find.

I searched marriage bonds in the following counties in an effort to find a marriage of Jacob Hunter to Polly .....:
Orange, Wake, Duplin, Guilford, Cumberland, Rowan, Granville, Cabarrus, Buts, Surry, Johnston, Bertie, Edgecombe, Warren, and Nash. Also Chowan, Perquimans and other Albermarle counties. None was found.

Wake County was formed from Orange, Johnston and Cumberland, so these were the logical counties, but in searching the others I took a sort of cross section of the state.

I have delayed in writing you, hoping that I would be able to talk at length with Dr. Rugus I. Hunter, who is well posted on the Isaac Hunter family, but he is tied up all this week with the Baptist Convention here.

It is a singular coincidence that my friend Clyde H. Hunter of Wake County has your name. I talked with him, but he comes down through James Hunter of Alamance County and this lineage runs back through Orange. I examined all these wills. Clyde H. Hunter says that his name came through his mothers' family, so there is no significance there.

There are two branches of the Chowan County Huhters here. Theophilus Hunter settled in Johnston(later Wake) in 1752. He died in 1798, leaving children; Henry, Martha Green, Elizabeth Hunt, Delilah, Edith, Irene and Polly.

The other branch was the Isaac Hunter Branch--Isaac "of S.C." famous

for the Isaac Hunter Tavern, etc. A highway market has been erected to him. Both of these men were prominent in civil and military life. See N.C. Colonial and State Records by Saunders and Clark.

The other Isaac-of S.C. was less conspicuous, but was a prominent and influential citizen.

As I have stated, we do not know at this writing what became of Jacob Hunter, who settled about the same time in Take that the two Isaacs did. Then I can have an opportunity to talk to Dr. Rufus Hunter, perhaps I can get more light on the subject, and shall write you.

There is still some hope that Jacob of Wake may have gone to South Carolina. You have all the records and will be able to analyze the data better than I can.

I am in receipt of your letter of the 17th for which I wish to thank you.

First I want to assure you that it is my hope that I shall be able to help you not only in the county of Wake, but through the records of North Carolina (those centralized here in our Archives and at the several court houses) as well as those in Virginia. My indexes and data accumulated over a period of many years usually lead me into the right channels of research.

Your attitude of taking a gambling chance is appreciated, however. It is because many people do not recognize the element of chance in this work that I make it a rule to ask for a check in advance of the search. But in this case I regard it as unnecessary.

Preliminary to taking up this search seriously I have made a geginning at the Wake County Court House.

These abstracts were taken hurriedly and I failed to take book and page to all of them, but will furnish them later.

I read a good many deeds in an effort to determine if possible Jacob Hunter's last transactions as a grantor. But there were evidently two Jacob Hunters. If you will note, there is a space of thirty-four years between these two transactions.

It may be that the first Jacob was a brother to Isaac. In as much as there were many transactions of Jacob after 1820, which was too late for your man, they may have been transactions of Jacob, the son mentioned in Isaac's (d. 1831) will.

I did not have time to go into the Grantee indexes, nor have I had time to give these data the study that I shall after I hear from you.

Inasmuch as we make it a policy to work from the earliest death date (last will and testament) to the net preceding, I would like to know when Jacob Hunter who went to Tennessee died and where he work from a data sheet such as I sent you in order that I may have all the information possible bearing on the problem contralized on one sheet. Can you do this for me-that is to say, fill in the data sheet for as many generations as possible, giving all the information possible. I wish this only for the purpose of the help it will give me. At all event give me the data on your earliest known and proven ancestor, all that you can.

What I have given you here is only preliminary. I think the names are significant, though there is, of course, nothing conclusive here so far as I can see at this writing. After I get seriously into the search by going into the land grants and running my indexes of the wills here in the Archives, I shall study the data that I get in connection with the Hunter records that I have in my files from the several counties. At first blush I do not think it improbable that your man may have been the first Jacob shown here. Or he may have been another Wake Jacob. The name was popular name in the family, and I really have not determined yet how many there were in this county. The Isaac Hunter family is living here now, and I may be able to get information from them to supplement what I find in the records.

I give to my wife Elizabeth# Hunter one hundred and sixty acres of land whereon I now live including all the improvements thereon to her use & benefit. Also four Neguos namely Sam, Ellender, Ned & Nancy and one bed & stead and furniture one Mare & Colt the Mare called Fillis a bridle A Saddle two cows & calved her choice of three sows and pigs and a sufficient quantity of pork for her next year support. Also plenty of corn for the same year.

Thirdly

I give and bequeath to my nephew Dempsey Hunter --one Negro Man named Mason to him and his heirs forever. I also give to his son Allen Hunter one Negro boy named Levy to remain in the family until the said Allen comes to the years of maturity. I also give Brittain Nicholson Hunter son of said Demsey Hunter sixty three acres of land known by the name of the Pace tract to remain uncultivated until he comes to the age of twenty-one years.

Item

I give to Allen Teasley one Negro boy named Simon to remain in the family until the said Allen Teasley comes to Daughter of William Faust, of Richland County, So. Car. See Exhibit 18.
