## Emmanuel Hunter Cabin Dedication, October 17, 2007

Dr. Robert L. Mees, President of John A. Logan College, the Logan College Board of Directors, the Board of the Harrison Bruce Foundation, and representatives of the Jacob Hunter Trust held an impressive dedication ceremony on October 17, 2007 opening the historic Emmanuel Hunter cabin to the public. The ceremony included period dress, a musical group, Civil War re-enactments, and pioneer life demonstrations. Many Hunter descendants attended along with local dignitaries and College officials. Local television and newspapers covered the event. A picture of the cabin was also placed on the cover of the John A. Logan College class catalog. Logan staff will clear the fencerow between the cabin and IL Route 13 so the cabin will be easily visible to all who travel the main highway through Southern Illinois.

### Richard Hunter's Remarks at the Cabin Dedication:

I am very happy to see this day finally arrive! The reconstruction of Emmanuel Hunter's log cabin as part of John A. Logan's historical village is definitely worth celebrating. There are many I would like to thank:

# Gifts and Bequests to the Jacob Hunter Trust

Your gift or bequest can help to assure that the Jacob Hunter Cemetery and the Allen Hunter Cemetery can be restored and maintained for eternity. The easiest way to accomplish this is to make gifts from time to time. You can do so by making checks payable to "Jacob Hunter Trust" where funds will be strictly controlled and used only for purposes that are consistent with the trust objectives.

You can remember the trust in your will. A simple bequest, as follows will suffice: "I give and bequeath to the Jacob Hunter Trust, a trust created to preserve the burial grounds of descendants of Jacob Hunter in Williamson County, Illinois, the sum of \$(amount)."

Another simple way to make a gift to the trust is known as the payable on death account (POD). You can open such an account at your bank or savings and loan. You open this kind of account by creating it in the name of "(Your name) Payable on Death to the Jacob Hunter Trust." The Trustee is Richard H. Hunter, 10202 Briggs Road, Marion, IL 62959-5844.

There are numerous advantages to such an account: 1. you retain full control over it as long as you live, 2. you can increase or decrease the amount or close it out without notifying anyone, 3. you are entitled to the income therefrom as long as you live, 4. it is entirely confidential. The only difference between it and any other account you own is that, upon your death, the balance that is in the account is paid to the Jacob Hunter Trust. The Jacob Hunter Trust is registered with the IRS as a tax-exempt 501 (c) (13) organization.

By contributing to the Trust, you will be strengthening our efforts to preserve family cemeteries, compile further historical information, and share information with interested relatives and selected public libraries.

## Dempsey Hunter 1745-1833 and William David Hunter 1775-1861

Jacob Hunter (1755-1806), the Revolutionary War Soldier for whom this Trust is named, is thought to have had 4 brothers - Dempsey, Thomas (b. 3-17-1763, d. 2-27-1834), Allen (b. before 1764, d. 5-13, 1820), and William David. Thanks to a letter from Mr. Wallace Williams of Birmingham, AL to Richard Hunter, Editor of the Jacob Hunter Trust Newsletter, we can now straighten out some of the relatives of William David Hunter and Dempsey Hunter. William David is thought to be Jacob Hunter's youngest brother. Dempsey Hunter is Jacob's older brother as is stated in

the Will of Allen Hunter, in which he mentions Dempsey, along with Jacob Hunter, son of Emmanuel Hunter. Dempsey's son John T. Hunter has at least three children buried in the Marshall Cemetery (# 15, 21, & 22). Letters written by John T. verifying Dempsey's service in the Revolutionary War and stating he is Dempsey's son can be found on Ernest E. Hunt's website at <http://www.mindspring.com/~hunter-family/index.htm>. Allen Hunter's Will is also available at this website.

Mr. William's letter contained copies of some grave stone inscriptions located in the Marshall Cemetery, 7343 Old Hickory Blvd., Whites Creek, TN. The inscriptions are found at the following web address: [http://davidsoncocemeterysurvey.com/Cemeteries/M/marshall\\_cemetery.htm](http://davidsoncocemeterysurvey.com/Cemeteries/M/marshall_cemetery.htm). In addition to William David Hunter and his wife Sarah, it is believed that most of the Hunters listed in this cemetery are sons, daughters, and relatives of Jacob's brothers William David and Dempsey Hunter. The following represents the Hunter grave inscriptions:

The Marshall Cemetery is near Whites Creek, TN, just a few miles East of Ashland City where Jacob Hunter lived. This suggests that Jacob and his four brothers moved to Tennessee (Jacob in 1793) and lived in the same general area.

## A Visit To Ashland City, TN: Murry & Susie Hawkins' Home

On January 10, 2008 Lawrence Lee Hunter, Thomas E. Hunter, and Richard Hunter traveled to Ashland City to visit the old Lee and Hunter family home sites. Murry Hawkins and his wife Susie presently own the home that was believed built by Braxton Lee for his second wife Mary Polly Dancer Hunter, widow of Jacob Hunter and mother to Jacob Hunter's children. Mary Polly married Braxton Lee on May 20, 1808, the same day that her son Emmanuel Hunter married Braxton Lee's daughter, Judith Lee (Father and daughter marrying mother and son).

The Hunter and Lee plantations were located on the north banks of the Cumberland River. Jacob Hunter purchased 220 acres on October 15, 1798 on both sides of Sycamore Creek where it joined the Cumberland River. The Lee Plantation was east of the Hunter land on the Cumberland River at the mouth of Marrowbone Creek. Braxton Lee and Jacob Hunter were good friends as well as neighbors.

It is believed that around 1811, 3 years after marrying Mary Polly Dancer Hunter, Braxton Lee built a home for her on a hill east and south of the original Lee home place. On an interior wall is the inscription "1811" and on a facing wall are the initials "MP." It is believed that MP was for Mary Polly and 1811 was the probable year the home was completed. The home sits high on a hill with a beautiful view overlooking what was the Lee Plantation (called Leeland Station), the Cumberland River, and what is now Ashland City.

Murry and Susie Hawkins were generous hosts and allowed us to visit their home and take pictures. They are outstanding guardians of this historic home. Murry, as City Manager of Ashland City, was instrumental in keeping previous developers from tearing down the home when a residential development was being planned. Murry and Susie have made improvements to the home, as did the previous owner, country music artist Randy Travis. Travis used the home as an office.

# The Old Lee Cemetery

During our visit to Ashland City on January 10, 2008 we (Rich Hunter, Lawrence Lee Hunter, Tom Hunter, and Murry Hawkins) had the opportunity to survey the yard at 104 Hibiscus Drive where the Old Lee Cemetery is located. This is where Jacob Hunter, namesake of the Jacob Hunter Trust, is buried, along with Braxton Lee, Elizabeth Ann Hatcher Lee, and Mary Polly Dancer Hunter Lee. We located 9 adult graves and one child/baby grave.

In talking with the present owners, we learned that they are planning to sell this property in the next 2 to 3 years. The brick building to the east is an apartment complex. We are concerned that a developer might purchase this property and build additional apartments, thereby destroying this historic cemetery. The Jacob Hunter Trust is interested in ideas people have that would allow us to purchase this property, add a fence around the cemetery, and provide ongoing maintenance.

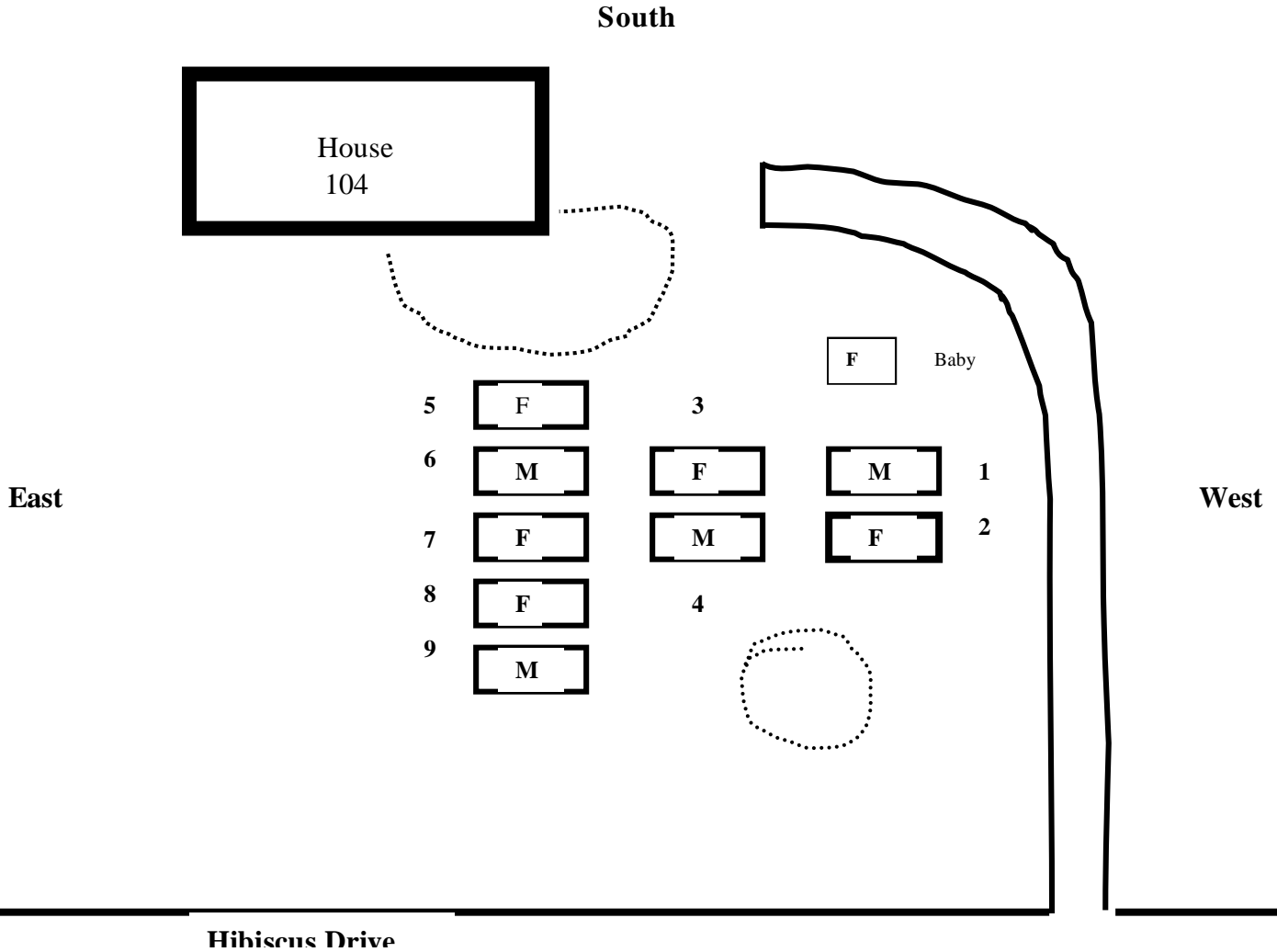

### Sketch of the Old Lee Cemetery, 104 Hibiscus Drive, Ashland City, TN



Rough sketch of graves located January 10, 2008 by Rich Hunter, Lawrence Lee Hunter, Thomas Hunter, and Murry Hawkins.

Buried in this cemetery are Braxton Lee (b. 8/2/1766, d. 1841) (1 ?); Elizabeth Ann Hatcher Lee (b. 7/7/1768, d. 11/23/1807) (2 ?); Mary Polly Dancer Hunter Lee (b. 1770; d. 1842-1850) (3 ?); and Jacob Hunter (b. 1755, d. 1806) (4 ?).

This property was part of the Braxton Lee Plantation (Leeland Station) and his original home was south and slightly east of this location.

## The Fate of Leeland Station Meeting House

In 1834 Braxton Lee deeded 2 acres of land for a church that was known as "Leeland Station Meeting House." This log structure later became known as "Forest Hill Church" and was used by all congregations. This church was used also as the county courthouse of Cheatham County from about 1857 to 1860. In 1913 this church was torn down and the logs were used to build a residence located in front of the Cheatham County Central High School. [Information taken from a letter written by James "Bud" Hallums on 5/20/1965 to Lorene Cruse of West Frankfort, IL] The letter is presently in the files of the Jacob Hunter Trust. The original location of Leeland Meeting House was at Forest Hills Cemetery where the present mausoleum sits.

On our January 10, 2008 visit to Ashland City, we found that the residence constructed with the logs from Leeland Station Meeting House/Forest Hill Church was being torn down. Lisa Walker contacted County Mayor Bill Orange and was informed the logs will be moved to land next to the Cheatham County Library where the County Museum is located.
